Terms of Use

By registering for The Gentleman Jim's VIP Club (Rewards Program) you agree to these Rules of Use:

ELIGIBILITY: Rewards Program is only available to legal residents of the United States and the District of Columbia who are 18 years of age or older when they enroll. Only one account is allowed per Member and a maximum of four accounts are allowed per household. The Gentleman Jim's employees are not eligible to participate.

ENROLLMENT: In order to enroll as a "Member" of Gentleman Jim's Rewards, you must register your card/sign up either online at <http://gentlemanjims.biz/vip-club-account/> or through text to join (GENTJIMS to 55678) and provide Gentleman Jim's Restaurant with your name, email address, phone number, address, and birthday.

EARNING REWARDS: Members will not receive points on any coupon or promotional offer; points will only be issued for the amount of money actually spent during the visit. Points will not be issued for gift card purchases, taxes, or gratuity. Members will receive a receipt after every purchase which will serve as a confirmation that your points were credited to your account.

REWARDS: A \$10.00 Reward will be loaded to your card every time you reach \$100.00 in valid purchases! Your Reward Dollars can be used for food and beverage in store. You will also receive a complimentary Appetizer (up to \$9.99 value) on the first day of the month that your birthday falls. You must present your Gentleman Jim's VIP Club card, or phone number associated with your account to redeem your Rewards dollars and they cannot be combined with any other coupon, discount or Gentleman Jim's Reward. You cannot use your Rewards dollars towards the purchase of gift cards, tax or gratuity. Gentleman Jim's Restaurant in its sole discretion may also award Members additional points and other rewards, e.g., free food, for the Member's specific behavior or special events. Rewards have no cash value.

EXPIRATION: Rewards will expire 60 days after they are earned, unless otherwise indicated on the Reward.

SUSPENSION/TERMINATION: Gentleman Jim's Restaurant reserves the right in its sole discretion to suspend a Member's membership in the Rewards program in the event of any suspected misconduct, including suspending the Member's ability to redeem Rewards and/or other rewards earned in connection with his/her membership in the Rewards program. If Gentleman Jim's Restaurant concludes in its sole discretion that the Member has engaged in misconduct or that his/her account has been compromised, it may terminate the Member's membership, including but not limited to terminating the Member's ability to redeem Rewards and/or other rewards earned in connection with his/her membership in the Gentleman Jim's Rewards program.

MODIFICATION: Gentleman Jim's Restaurant reserves the right in its sole discretion, to terminate the Rewards program, and to alter, limit, modify, or add to the Rewards Club rules, regulations, terms and conditions. This includes, but is not limited to, imposing time limits and changes in Reward values, Rewards, and Reward levels, all without prior notice, at any time. Any such changes are effective immediately and the Member's continued enrollment in the Gentleman Jim's Rewards program confirms that he/she accepts the changes and agree to be bound by them.
